1. Reasons for closing down of the operations is as mentioned in the Notice dated 29th September, 2018. Copy of Notice is enclosed.
2. The number of employees on the date of closing down of the operations was 44. Copy of manpower statement is enclosed.
3. Services of all the employees were determined and they were paid compensation as per Law.
4. Closing down of operations is permanent unless new organisation takes over.
5. In respect of storage of chemicals, there is no Methanol in stock, which was raw material. The quantity of finished product Formalin is less than three tons. To ensure safety of chemical round the clock security is available including all fire fighting equipment and trained security personnel.
6. All the employees have been on the day of closing down of operations paid wages in lieu of earned leave at their credit as well as earned by them during the current year. Particulars of encashment of leave is enclosed.


8. There are no outstanding amount/s in respect of workmen. A copy of declaration in this regard is enclosed.
